Tenure:

1. Candidates who studied Post graduation in **Government Medical & Dental Colleges** of Andhra Pradesh are only eligible to apply.

2. Local candidates are only eligible to apply.

2. **On line procedure.** Candidates has to login to DME official website – <http://dme.ap.nic.in>

3. The candidate has to enter his / her details, and submit the application with relevant data.

4. The candidates has to pay the application fee Rs. 500/- for OC and Rs. 250/- for BC,EWS,SC and ST candidates.

3. In case of more than one candidate is having the same marks, Date of Birth will be taken into consideration and elder person will be given first preference.
4. The selection committee also reserves its rights to alter or modify regarding conditions laid down in the notification for final selection and also posts notified.
